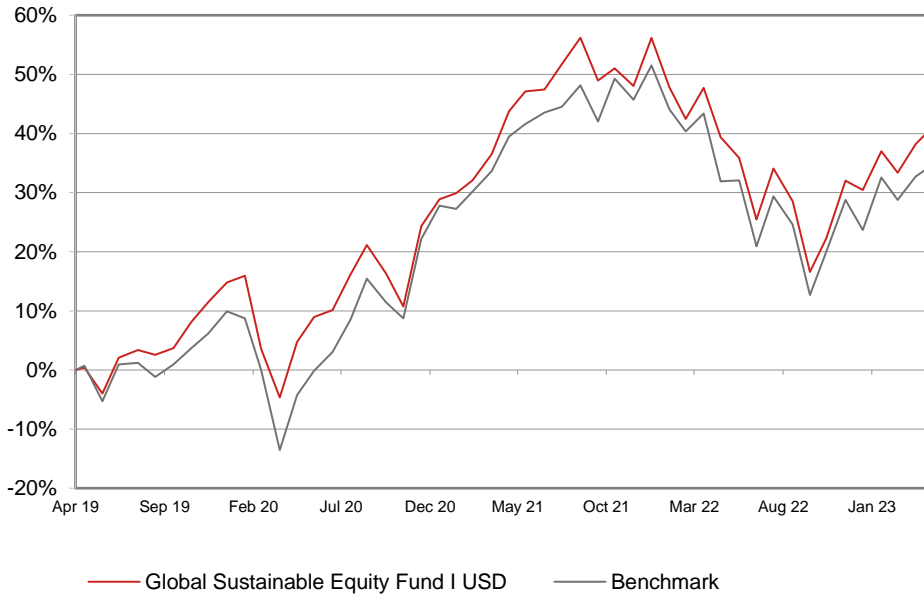


INVESTMENT OBJECTIVE

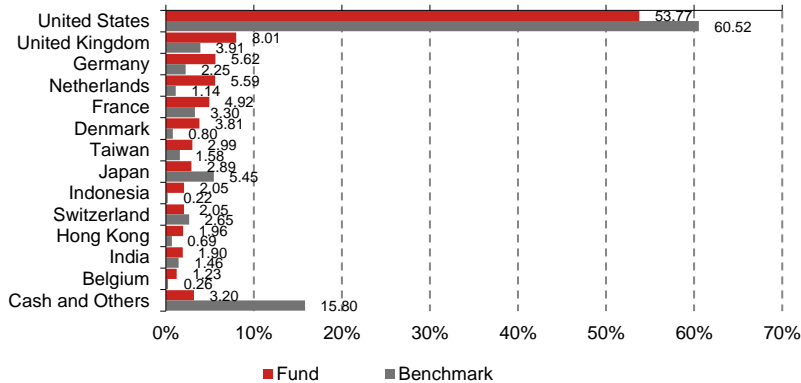

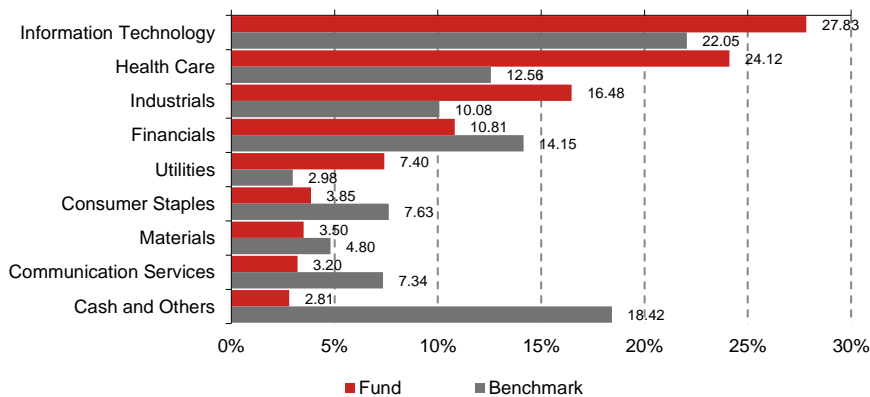
